



Now This DEED OF TRUST Witnesseth :-

1. NAME : The name and style of the Trust shall be " P.K.S. EDUCATION TRUST "
2. ADDRESS : The registered office of the Trust shall be at : Sampigehall, Jakkur Post, Yalahanka Hobli, Bangalore North Taluk, and may be shifted to other place or places as may be decided upon by the Board of Trustees from time to time. Branches may also be opened anywhere in India.
3. AREA OF OPERATION: The area of operation of the Trust shall be within the territorial jurisdiction of the Union of India.
4. AIMS AND OBJECTIVES :
  1. The Trust fund shall consists of such contribution, donations, subscriptions, endowments, settlements made by the public Government institutions, statutory corporations and the like for the purpose of advancement and objects of the Trust, such acquisitions and accretions to the properties of the Trust as may be made by the trustees, Income and profits from the properties of the Trust. The properties and the assets of the Trust shall vest in the trustees for the fulfilments effectation of the objects and purpose of the Trust.

5. To establish, promote trust, School, Colleges, Libraries, book trustees, reading rooms, technical institutions, research Institutes and other public charitable Institutions or societies.
6. To hold and promote education and learning including primary, higher and college educations (Technical and Non Technical) Agricultural, Engineering, Medical Commercial, Scientific, Philosophic or any subject relating to Asian culture or any other subject of education and research work in all subjects in Schools, Colleges and other institutions.
7. To establish professorships lectureships and to give scholarships and prizes or any other similar held or encouragement for the advancement of educations, for the socially under privileged;
8. To establish maintain and support or help by monetary or otherwise, institutions such as libraries, fine art classes etc.

15. To honour Scholars of various Schools and also provide for subsistence when they are in indigent circumstances.
16. To do all such things as the Trustees may think proper and necessary for the attainment of the above objects.

23. To establish institutions for orphans, old age people and mentally retarded.
24. To establish and run hostels for poor children and students irrespective of caste, religion, race or social status.
25. To encourage the school going children to continue the formal education and non formal technical trainings.
26. To educate children regarding preventive measures to the Alcoholic and drug abuse.
27. To assist the organization at the time of natural calamities, such as earth-quake, flood, etc., by motivating the children and the general public.
28. To establish, run and administer educational institutions and activities in all branches at all levels for the benefits of students of all walks of life, irrespective of caste, creed and religion.

**5. TRUST PROPERTY :**

The trust property shall consist of

- 1. The Founder Trustees above-named have together contributed Rs. 5,000/- (Rupees Five Thousand Only) with an intend that the same TOGETHER with other donations that may be received in due course by the Trustees as such. Trustees shall use for the Trust purposes and hold the same on the Trust as hereinafter setout.
- 2. Contributions, gifts, donations, endowments, incomes and amounts received by the trust in future.
- 3. Properties, movable and immovable acquired by the trust transfer, taking over, assignments, purchase, gift, entrustments, lease or by any other mode.

**6. CONSTITUTION AND MANAGEMENT :**

- 1. The founder trustee along with the other trustees shall be collectively and compendiously referred to as "Board of Trustees" and all the funds, Properties, rights, claims and demands of every description belonging to or pertaining to the trust and which may be acquired by the trust from time to time shall vest in the board of trustees.

2. The lifetime trustee/s shall have the powers to nominate his successors with the consent of the board of trustees. After his lifetime or in the event of his being incapacitated, his successor shall assume the office as the life trustee. Such successor to the life trustee and his successors shall also have all the powers as the life trustee and shall be entitled to nominate their successors. Each successor shall also be entitled to nominate their successors. Each such successors shall also be a trustee for life, unless he is incapacitated herein above, in which case, he shall cease to be the life trustee as soon as such incapacity occurs and all the provisions of this trust deed relating to the successors to the office of the life trustee shall apply accordingly. In case no successor has been nominated by the found trustee of the life trustee or any of his successors, the "Board of Trustees" as constituted at the time of occurrence of the vacancy in the office of such trustees, shall appoint any eminent person as the founder trustee or life trustee as the case may be and the person so appointed shall occupy the office for the same term and shall have the same powers conferred on them in the trust deed.
3. The other trustees shall be nominated by the existing board of trustees by election/passing resolution in the duly convened meeting with minimum two-third majority. They shall hold office of the trustees for five (5) years and are eligible for reappointment.
4. The board of trustees shall hold meetings at least once in six months at a place decided by it. Urgent matters may be decided by circulation of papers among the trustees by getting the written opinion.
5. The resolution passed in the duly convened meeting shall be valid with the approval of the Managing Trustee.
6. The quorum of the meeting shall be two thirds (2/3).

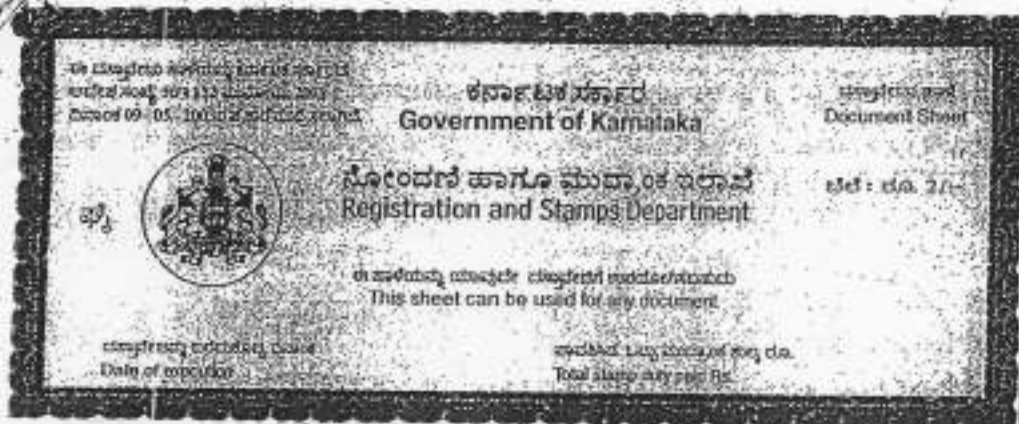

7. The resolution passed in the duly convened meeting shall be operative with the approval of the Managing Trustee.
8. A notice of at least 21 days shall be given to the trustees for attending the meetings. If a majority of trustees desire, meetings may be conducted at a shorter notice.
9. The other trustees of the trust shall hold office of the trustee for a period of five (5) years and are eligible for re-appointment. The board shall have the powers to remove any trustee at any time without assigning any reason for such removal.
10. The Board of trustees shall have absolute powers to appoint the other trustees with the written permission of the founder trustee and to decide upon their term of office.
11. The founder trustee, life trustees and other trustees shall constitute the 'Board of Trustees' and all matters shall be decided in the meeting of the 'Board of Trustees' by a minimum two thirds (2/3) majority of the members present and voting. In the event of equality of votes, the founder trustee shall have a casting vote.
12. Any trustee other than the founder trustee shall continue in the office unless she ceases to hold office for the following reasons :-
  - a. On his/her death.
  - b. On his/her resignation.
  - c. On his/her becoming seriously ill or insane.
  - d. On his/her becoming insolvent.
  - e. On his/her removal by the founder trustee.
  - f. On his/her becoming absent from the country for a prolonged period.

13. In case a vacancy occurs in the office of any trustees for any of the aforementioned reasons, the founder trustee shall nominate or appoint the successor to such trustee.
14. The strength of the Board of Trustees shall not exceed Five (5) and shall never be less than three (3).
15. It shall be the responsibility of the Managing Trustee to ensure that there shall be at least three (3) Trustees on the Board at all times.
16. The Board of Trustees can frame rules from time to time for regulating the periodicity of its meetings, the quorum and other such procedural matters. But where such rules framed are inconsistent with any of the provisions of this trust deed, the rules shall not operate and the provisions of these trust deed shall prevail.
17. The office of the trustees shall be honorary and the trustees shall not be entitled to any remuneration other than setting fees for carrying out their duties.

**7. FUNCTION AND POWER OF TRUSTEES**

Without prejudice to the generality of the power vested in them, the Board of Trustees shall have the following powers:-

1. To acquire by purchase, gift, grant, exchange, lease or otherwise properties of all kinds, both immovable and movable and to convert one kind of property in to another.
2. To improve or add to the corpus of the trust.
3. To sell, lease out or give license or otherwise dispose off or alienate all or any of the properties of the trust in good faith for the best interest of the trust and its beneficiaries.
4. To receive monies and to grant receipts and discharges thereof.

5. To borrow monies from banks and other persons for the purpose of the trust.
6. To institute, prosecute and defend all actions and proceedings and the like before the Governments, Courts, Tribunals, Revenues, Municipal and local authorities, Tax authorities etc., and to represent before them.
7. To enter into any compromise and to refer matter to arbitration.
8. To engage the services of any person or persons on such remuneration as the trustees deem fit and to terminate their services as also after the terms of their services.
9. To incur all the cost and expenses of the due and efficient management of the affairs and properties of the trust.
10. To invest all the trust funds in any form or mode provided that the investment shall be only in forms and modes authorized by Sec. 11 (5) of the Income Tax Act, read with Sec. 13 (1) (d) of the said Act, as mentioned from time to time.
11. To delegate to any person or persons all or any of the foregoing powers, subject, however, to their retaining control over the actions and conduct of the person to whom the powers are delegated.
12. To open and operate and provide for operation of bank accounts.
13. To add or alter or abrogate or amend any of the provision of the trust provided, such amendment, additions or alteration shall not be repugnant to the provisions of the Sections 2 (15); 11; 12; 12A; 13 and 80G of the Income Tax Act, as amended from time to time, provided further that no such amendment shall be carried out without the prior approval of the Commissioner/Director of Income tax having jurisdiction over the trust.
14. All or any of the aforesaid powers may be exercised by the trustees who constitute the 'Board of Trustees' jointly or severally as the 'Board of Trustees' may decide from time to time.

**8. APPLICATION OF FUNDS AND PROPERTIES :**

The trust properties shall not be distributed amongst the trustees or other persons under any circumstances.

**12. ACCOUNTING YEAR :**

The accounting year of the trust shall be the period commencing from 01 April of the year to the 31<sup>st</sup> March of the succeeding year.

**13. BANK ACCOUNT :**

The Bank Account of the Trust shall be opened in any Nationalized Bank. The Managing Trustee and one of the Trustees authorized by the Managing Trustee shall be entrusted by the Trust to operate the Bank account with powers to sign the cheques of all withdrawals of the Trust Funds.
